


## Showcase presentation: Gateshead Fertility

Isaac Evbuomwan and Sophia Jewitt





- Providing specialist fertility treatment at QEH since 1996
- NHS and private-patients, from the whole northern region
- Regional Units are Newcastle, Middlesbrough, Darlington (pp)
- Expansion from 60 IVF cycles/year to providing 600 treatment cycles to a diverse range of patients.
- <u>Ambition</u>: to proactively seek patient groups who are not accessing treatment and develop the range of services provided



### Strict Orthodox Jewish community

- Bensham is the 3<sup>rd</sup> largest community in UK
- Historically, patients chose to travel to Manchester or London
- Idiosyncratic, faith-related barriers to accessing services
  - Menstrual timing, sperm production issues, witnessing IVF

#### IMPROVE ENGAGEMENT & EMBRACE DIVERSITY

- Period of engagement with local Jewish leaders
- Understanding of Halachal laws ie. "code of conduct"
- Negotiate an adapted pathway for fertility investigations,

treatment and laboratory procedures






### LGBT+ community

- Desire to achieve parenthood via regulated fertility clinics
- Dramatic increase in demand nationally since 2019
  - +22% increase in donor sperm treatments
  - Female same-sex couples undergoing IVF has increased by +33%

### For those who don't know who we are ..

- South of Tyne region population of 693,379 in Gateshead, South Tyneside and Sunderland. Colposcopy services are based at:
  - Queen Elizabeth Hospital Gateshead
  - Sunderland Royal Sunderland
  - South Tyneside Hospital
- Since June 2014, cervical screening and histology services consolidated into The Pathology Centre at Gateshead Pathology (thepathologycentre.org)
- As of 2019 the Gateshead Cervical Screening service became one of 8 national laboratories providing Cervical Screening for the whole of the North East and Yorkshire.







### Regional information..



In Gateshead, the latest NHS data shows that nearly 28,000 women between the ages of 24-49 years, and more than 10,000 between the ages of 50-64 years, are not up to date with their cervical screening.

These figures are in line with the latest national figures from the DOHSC Care which show nearly 30% of women and people with a cervix aged between 25 and 64 years are not up to date with their cervical screening. There is a broad and complex range of reasons why women and people with a cervix do not attend their cervical screening.

Cervical cytology uptake is consistently higher than national average in the North East. Most recent figures from 2021-2022 show the local coverage:

CCG	25-49yrs age	50-64yrs age
Newcastle/Gateshead	68.5%	75.7%
South Tyneside	76.5%	75%
Sunderland	73.4%	77.2%

Most recent national figures from 2021 show 75.5 % age appropriate cytology coverage for those with a cervix in the North East, which still falls under the 80% recommended population coverage

Gateshead were chosen as part of a pilot scheme to encourage attendance and raise awareness. As part of the wider campaign, educational leaflets and posters were circulated to GP practices throughout Gateshead.

A campaign website was built providing credible information, together with a film containing open and honest discussions about cervical screening: Let's talk cervical screening (cervicalcancer-risk.com)



#### Colposcopy

- Review over 2000 patients per annum from the Gateshead and South Tyneside area ever increasing
  referrals into the service. Referrals consist of direct screening referrals, 2ww and other urgent/non urgent
  referral from both primary and secondary care colleagues
- More than screening. We undertake diagnostic biopsies and LLETZ treatments for both pre invasive CIN/CGIN and diagnostic LLETZ for as well as treatments for early stage 1A1 cervical cancers. We review and monitor and treat pre invasive and early stage invasion of the whole lower genital tract – Encompassing the cervix, vagina and vulva
- We also complete follow up for the early stage cancer cohort back within the colposcopy service. A true success of the NHSCSP screening programme as we have aided to avoid more extensive cancers requiring more surgical, physiological and psychological resources
- Annual patient satisfaction survey 2022 87.7% (154 responses) rated the service Excellent! 11% rated this as good!

Albeit with long term struggles with poor estate which is not deemed fit for purpose - Service overcomes challenges and provides high quality care with frequent positive patient reviews SQAS quality assurance service review January 2023 - 'The service is a credit to the trust!'



### HPV Primary Screening...

- Primary HPV screening launched nationally in 2020
- All cervical screening tests initially tested for one of 14 strains of human papilloma virus
- Only require cytology slide if HPV positive
- At minimum a 60% increase in referrals noted nationally in pilot sites
- Anticipated decrease of these referrals... however broadly this has not yet been seen and referral figures continue to increase into Colposcopy clinics
- Gateshead used to run 4-6 colposcopy clinics per week in 2015 Now providing 10-12 per week and the service is looking at requiring to provide 14 clinics per week

#### Flash mob...

Gateshead Health NHS Foundation Trust Staff, in partnership with Roche Diagnostics UK and Ireland took part in a "Flash Mob" at The Angel of the North.

The Flash Mob was held at on 24<sup>th</sup> June 2023 and was staffed by the Lead Colposcopy nurse and screening staff to hand out information and answer any questions people may have had.

Part of an ongoing public awareness campaign called Let's Talk Cervical Screening

The campaign aims to educate women in Gateshead and the surrounding areas about HPV and cervical screening as well as helping alleviate any concerns when it comes to booking an appointment.

The flash mob was a creative way to remind of the importance of the test and share information that can help reduce some of the anxieties that exist. We need to dispel the myths around cervical screening and break down apprehensions, and this was a great and fun way of communicating these messages.



## Event planning...

- Weeks leading to the event: Lead nurse worked with local DJ whom volunteered his time and SDC collated a list of songs that talked through the process of screening from receiving the letter to book the appointment...embarrassment...fear of results... through to a reminder to re attend when recalled
- Work with the trust communications team to ensure council permits, press statements reviewed alongside ROCHE and also to ensure trust communications were placed out to raise awareness/support for the event. Work with estate team to ensure we had power also for the event
- Lab staff organised mini training session in lunch break to go over 'the moves' SDC had completed a video demonstrating the moves required so those wishing to be involved could practice
- Day Before NO SOUND. Sound technician could not get his £14k kit to play. Cue an emergency dash to Teesside for SDC to pick up a specific cable. Sound all confirmed on the morning of the event.
- Day of the event; Fantastic turnout and the sun shone! Regional colleagues also turned up to support the event. Positive articles in both regional and national press about the event.

- Work with local Transgender groups 'T&Coffee' to improve access and reduce fear and/or anxieties in attending screening and colposcopy
- Successful NHSE capital bid for further equipment for Colposcopy to aid with on going increase of demand within the service
- Further bid made to regional NHSE re development of a Colposcopy website; interactive videos to encompass engagement and improvements to the service and reduce health inequalities – awaiting update
- SDC Development of staff cervical screening programme within the trust Equally this will bring internal development and opportunities for B5 nursing staff to develop skills that will help them with career progression and aid retention within the women's health remit




#### Future plans ctd...

- SDC Service improvement project to look at the development of psychosexual services for those with pre-invasive conditions of the lower genital tract – Large group not necessarily supported
- Development of nurse led vulval review clinics (currently x1 experienced nurse undertakes reviews of MZIN/Vulval patients as part of colposcopy activity)
- SDC current Lead trainer for the service both medical and nursing staff Aim to increase department trainers and ensure quality assured consistency remains as part of this
- SDC Long term aim to work alongside Honiton and local colorectal/surgical colleagues to look at the introduction of Anoscopy to the service. This will allow us to become a further regional specialised centre for multi zonal abnormalities
- Estate Clinic facilities deemed not fit for purpose by both trust and SQAS team action plan.



## **Constitutional amendments for approval**

- 1. Reclassification of volunteers from staff constituency to public constituencies (means that any public Governor can be a volunteer and supports volunteers to become Governors without a cap on numbers)
- 2. Widening of geographical boundaries of the out of area constituency to align to the North East and North Cumbria Integrated Care System boundaries (aligns with the role of the Board and Council to consider the public at large in decision-making)








